DESCRIPTION OF WORK

The Architectural Consultant provides architectural design, design review, technical consulting and related professional services for construction projects at historic sites and museums administered by the Pennsylvania Historical and Museum Commission. This position is responsible for planning and managing projects on some of Pennsylvania's most important historic sites and gets to ensure the sites and museums that tell the history of Pennsylvania are in good condition for the visiting public. Work includes overseeing renovation and new construction projects for conformance and compliance with current building codes and the Secretary of the Interior Standards for the treatment of Historic Properties.

REQUIRED EXPERIENCE, TRAINING & ELIGIBILITY

Qualifications:

- **Minimum Experience and Training Requirements** - One year as an Architectural Designer 2; **OR** three years of professional architectural experience in building renovation or preservation and new construction for commercial, institutional, government, or educational buildings or structures, and a bachelor's degree in architecture, architectural engineering, or a closely related field which included major course work in architectural design; **OR** an equivalent combination of experience and training.
- **Special Requirement** - All positions require active licensure as a registered architect by the Commonwealth of Pennsylvania or a reciprocal jurisdiction; or

an active certification as issued by the National Council of Architectural Registration Boards (NCARB).

- Based on your answers to the supplemental application questions regarding education, you may be instructed to upload a copy of your college transcripts to your application. Unofficial transcripts are acceptable.
- Based on your answers to the supplemental application questions regarding licensure, you may be instructed to upload a copy of your license to your application.
- Must be able to perform essential job functions.
